



PRIZE DRAW TERMS & CONDITIONS

1. The Promoter of the prize draw is Celtic FC Foundation, a Scottish Charitable Incorporated Organisation with registered number SC024648 and having its office at Celtic Park, Glasgow G40 3RE (the “**Promoter**”).
2. By entering the prize draw entrants agree to be bound by these terms and conditions (“**T&Cs**”). The Promoter reserves the right to verify the eligibility of any and all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements.
3. Employees of the Promoter or any of its associated companies or subsidiaries are excluded from entering the prize draw.
4. In order to enter the prize draw, an entrant must either: (i) sign up to the Promoter’s *Walfrid’s Wish* campaign between Friday, 26 July and midnight on Friday, August 2, 2019; or (ii) be an existing member of the Promoter’s *Walfrid’s Wish* campaign. For the purpose of the prize draw an entrant who meets either of the conditions shall be deemed to be a “**Qualifying Renewal**”. Each Qualifying Renewal will be automatically entered by the Promoter into the prize draw.
5. The winner will be the first Qualifying Renewal to be drawn at random by an independent person on Monday, August 12, 2019. The winner will be notified by a representative of the Promoter, using any relevant contact details on the Promoter’s database, on or before Friday August 16, and may be asked to provide further information to facilitate the delivery of their prize. The Promoter reserves the right to re-draw the winner if they cannot be contacted within a reasonable period of time (to be established at the Promoter's sole discretion).
6. The prize shall consist of a premium package for two, including premium padded seats in the Jock Stein Stand, with access to the Kerrydale Suite, plus food and beverage vouchers (the “**Prize**”).
7. There is only one Prize and it is non-transferable.
8. The winner will be required to give their consent to the following: (i) the winner's name to be included in any marketing materials sent out by the Promoter; and (ii) the winner's name and/or photograph to be published for promotional purposes.

If the Promoter cannot successfully contact the winner within a reasonable length of time, or if the winner is unable or unwilling to accept the Prize, or if the winner does not meet the eligibility requirements, or the winner does not provide the consent requested at paragraph 9 above, a re-draw will take place until a new winner is found who is able, willing and eligible to accept the Prize. This new winner shall be deemed to be the winner for the purposes of these T&Cs.
10. The Promoter reserves the right to cancel or amend the prize draw or these T&Cs without notice when reasonably necessary for the purpose of administering the prize draw.
11. The prize draw, together with these T&Cs, is governed by Scots law and the Scottish Courts will have jurisdiction over any proceedings in connection with the prize draw.
